We assist clients with obtaining a number of non-immigrant visas that allow foreign nationals to work in the U.S. We have extensive experience helping clients navigate the complex regulatory and procedural maze to secure the following non-immigrant visas: practical training for F-I students, TN for Canadian and Mexican professionals admitted under NAFTA, H-IB and E-3 for specialty occupations, L for intracompany transfers, E-I/2 for treaty traders/investors, O-I for extraordinary ability workers, B-I for business purpose visitors, and P for performers and athletes.

We routinely process permanent resident petitions in accordance with established guidelines and policies for employment-based visas, family-based visas, and annual diversity visa lotteries. We prepare J visa waivers and naturalization applications for U.S. citizenship.
